

USS started its activities in 1997 at Sadar Upazila of Nilphamari District. USS vision is democratic society free of poverty and inequality where all the people are enjoying freedom, self-reliant, confident and contributing to the development of country and nation as a citizen with democratic values.

To achieve the vision, USS facilitate a process among the marginalized people so that they can unmask the apparent and underlying causes of poverty and take initiatives to overcome the problems collectively.

USS is implementing all the programs in cooperation with national and international organizations, for instance, Research Initiatives Bangladesh, Green Foundation, Plan international, Bangladesh, USC Canada, Action Aid, Bangladesh, Bangladesh Freedom Foundation, Diakonia Bangladesh, Bangladesh NGO Foundation etc. However, it is important to mention that USS is getting support from local civil society, for instance to fund the program such as "Community Dhan Bank".

USS primary role as facilitator, in supporting people to critically analyze the situation, identify the causes, define the solutions, formulate the alternative vision, plan for action and strategies to achieve desired results.
